

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PROCEEDING WITH THE RENTAL OF OUR COFFEE TRUCK. BY CONFIRMING YOUR RESERVATION AND MAKING THE REQUIRED DEPOSIT PAYMENT, YOU ACKNOWLEDGE AND ACCEPT THESE TERMS AND CONDITIONS IN THEIR ENTIRETY.

RESERVATION AND PAYMENT:

- 1.1. TO SECURE YOUR RESERVATION, A NON-REFUNDABLE DEPOSIT OF THE RESERVATION FEE IS DUE AT THE TIME OF CONFIRMATION.
- 1.2. BOOKINGS 60 DAYS OR MORE IN ADVANCE REQUIRE 50% OF GUARANTEED MINIMUM PAID 30 DAYS PRIOR TO THE EVENT, WITH THE BALANCE DUE ON THE EVENT DAY, OTHERWISE ALL BALANCES ARE DUE ON THE EVENT DAY.

CANCELLATION AND REFUNDS:

- 2.1. IN THE EVENT OF CANCELLATION PRIOR TO 48 HOURS BEFORE THE EVENT, YOU FORFEIT THE NON-REFUNDABLE DEPOSIT AND A CANCELLATION FEE OF 10% OF THE REMAINING RENTAL FEE AND/OR GUARANTEED MINIMUMS, WILL BE CHARGED.
- 2.2. CANCELLATIONS MADE WITHIN 48 HOURS OF THE SCHEDULED RENTAL START TIME WILL RESULT IN A 25% CANCELLATION FEE.
- 2.3. TO CANCEL A RESERVATION, YOU MUST PROVIDE WRITTEN NOTICE VIA EMAIL OR OTHER WRITTEN COMMUNICATION.

RENTAL PERIOD:

- 3.1. THE RENTAL PERIOD BEGINS AT THE AGREED-UPON START TIME AND ENDS AT THE AGREED-UPON END TIME.
- 3.2. ANY EXTENSION TO THE RENTAL PERIOD MUST BE REQUESTED IN ADVANCE AND IS SUBJECT TO AVAILABILITY. ADDITIONAL CHARGES MAY APPLY FOR EXTENDED HOURS.

RESPONSIBILITIES AND USE OF THE COFFEE TRUCK:

- 4.1. THE RENTED COFFEE TRUCK IS TO BE USED SOLELY FOR THE PURPOSES OF PROVIDING COFFEE-RELATED SERVICES AND ASSOCIATED PRODUCTS.
- 4.2. THE COFFEE TRUCK SHALL BE OPERATED IN COMPLIANCE WITH ALL APPLICABLE LAWS, REGULATIONS, AND HEALTH AND SAFETY STANDARDS.

POWER REQUIREMENTS:

- 5.1. THE COFFEE TRUCK REQUIRES LEVEL GROUND AND ACCESS TO POWER DURING THE RENTAL PERIOD.
- 5.2. IT IS YOUR RESPONSIBILITY TO ENSURE THE AVAILABILITY OF THE APPROPRIATE POWER OUTLETS AT THE RENTAL LOCATION.
- 5.3. THE COFFEE TRUCK REQUIRES ONE 15/20-AMP STANDARD HOUSEHOLD OUTLETS WITHIN 75 FEET OF THE TRUCK.

GOVERNING LAW AND JURISDICTION:

- 6.1. THESE TERMS AND CONDITIONS SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE JURISDICTION IN WHICH THE RENTAL TAKES PLACE.
- 6.2. ANY DISPUTES ARISING FROM THESE TERMS AND CONDITIONS SHALL BE SUBJECT TO THE EXCLUSIVE JURISDICTION OF THE COURTS IN THE AFOREMENTIONED JURISDICTION.

ENTIRE AGREEMENT:

- 7.1. THESE TERMS AND CONDITIONS CONSTITUTE THE ENTIRE AGREEMENT BETWEEN YOU AND US REGARDING THE RENTAL OF THE COFFEE TRUCK, SUPERSEDING ANY PRIOR AGREEMENTS OR UNDERSTANDINGS, WHETHER WRITTEN OR ORAL.

BY CONFIRMING YOUR RESERVATION AND MAKING THE REQUIRED DEPOSIT PAYMENT, YOU ACKNOWLEDGE THAT YOU HAVE READ, UNDERSTOOD, AND AGREED TO BE BOUND BY THESE TERMS AND CONDITIONS.
